

**CHOD OPERATION ORDER FOR  
ALDEN BIESEN**

**AIRSPACE MEASURES FOR COG ALDEN BIESEN**

**1. Protection Zones**

This appendix provides an overview of the HVE protection zones layout and the airfields located in the TPZ and TFRZ in case of a Centre of Gravity located in Alden Biesen. These two zones will be activated by NOTAM after coordination between Crisis Cell, Skeyes and Defence.

**2. Temporary Prohibited Zone**

- A 13NM circle centered on 50°50'30" N 005°31'15" E, Amsterdam FIR excluded. GND / FL 195
- a. RPAS and VFR flights prohibited, excl SAR, State, medical, humanitarian, NATO flights and flights with a specific approval from the Crisis Cell of the Federal Public Service Interior.
  - b. All flights in this zone shall establish and maintain two-way radio communication with ATS:
    - (1) For Class C and D this will be as published in the AIP Belgium and Luxembourg
    - (2) For Class G this will be BELGA information on 129.325 MHz
  - c. Companies flying on State flight status shall contact Control and Reporting Centre Beauvechain 30 MIN before departure on +32 (0) 2 443 86 51 (or 650 or 653) and the crisis cell on +32 (0) 506 47 11 and add STS/STATE in their flight plan.
  - d. This also means that small aerodromes, which are situated inside of it, might be temporarily closed, except for the previously mentioned flight types.

**3. Temporary Flight Restriction Zone**

- A 30NM circle centered on 50°50'30" N 005°31'15" E, Amsterdam FIR excluded. GND / FL 195.
- a. CIV aerobatic flights, CIV RPAS/UAS, crop dusters, gliders, ULM, motorized delta planes, paramotors, banner towing, CIV paradrops and manned free balloons are prohibited.
  - b. All flights in this zone shall establish and maintain two-way radio communication with ATS:
    - (1) For Class C and D this will be as published in the AIP Belgium and Luxembourg
    - (2) For Class G this will be BELGA information on 129.325 MHz
  - c. All traffic, including local traffic, shall be issued a discrete Mode A code (designated SSR code given by Air Navigation Service Provider) or the conspicuity code A1000 with Mode S.
  - d. VFR flights, excl SAR, State, medical, humanitarian, NATO flights and flights with a specific approval from the Crisis Cell of the Federal Public Service Interior within this area:
    - (1) Shall be radio and transponder equipped.
    - (2) Shall submit a flight plan to Brussels ARO (EBBRZPZX) at least 60 MIN prior departure, which will also be sent to Steenokkerzeel ATCC via AFTN (EDYYBAFA and EBMIZGZF).

#### 4. Air Defence Identification Zone

- A circle of 60 NM centered on 50°50'30" N 005°31'15" E. GND / FL 195
- Not shown on maps, specific zone for the Situational Awareness of the CRC.

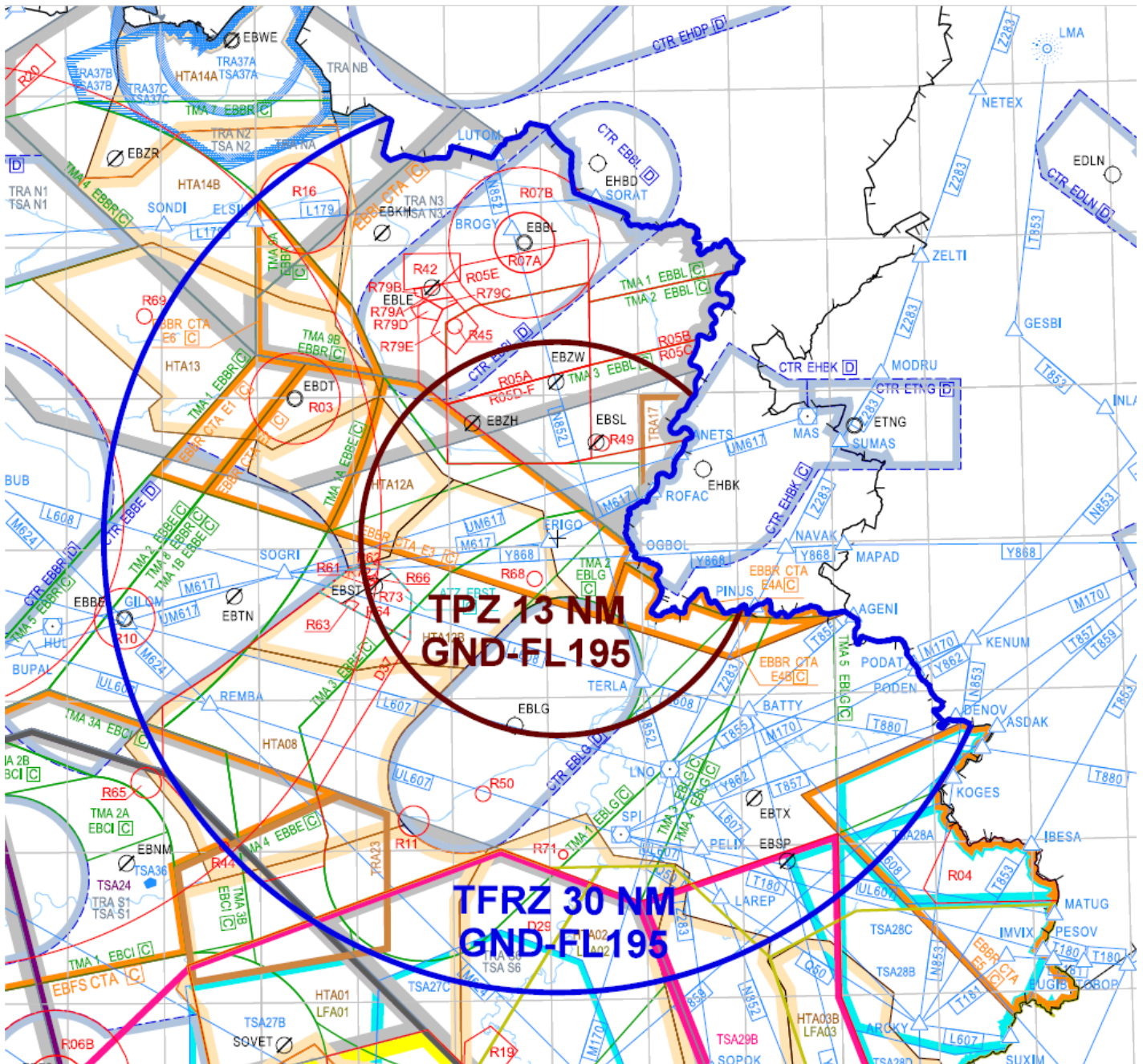


Figure 1: HVE protection zones for CoG Alden Biesen



## 5. Airfields

CIV airfields (except EBLG and Hospital heliports) inside the Temporary Prohibited Zone Brussels will need to be closed during NOTAM activation. Airfields in the TFRZ hosting air activity mentioned in §3.d will also need to be closed during this activation. One NOTAM per closed airfield will be published in due time.

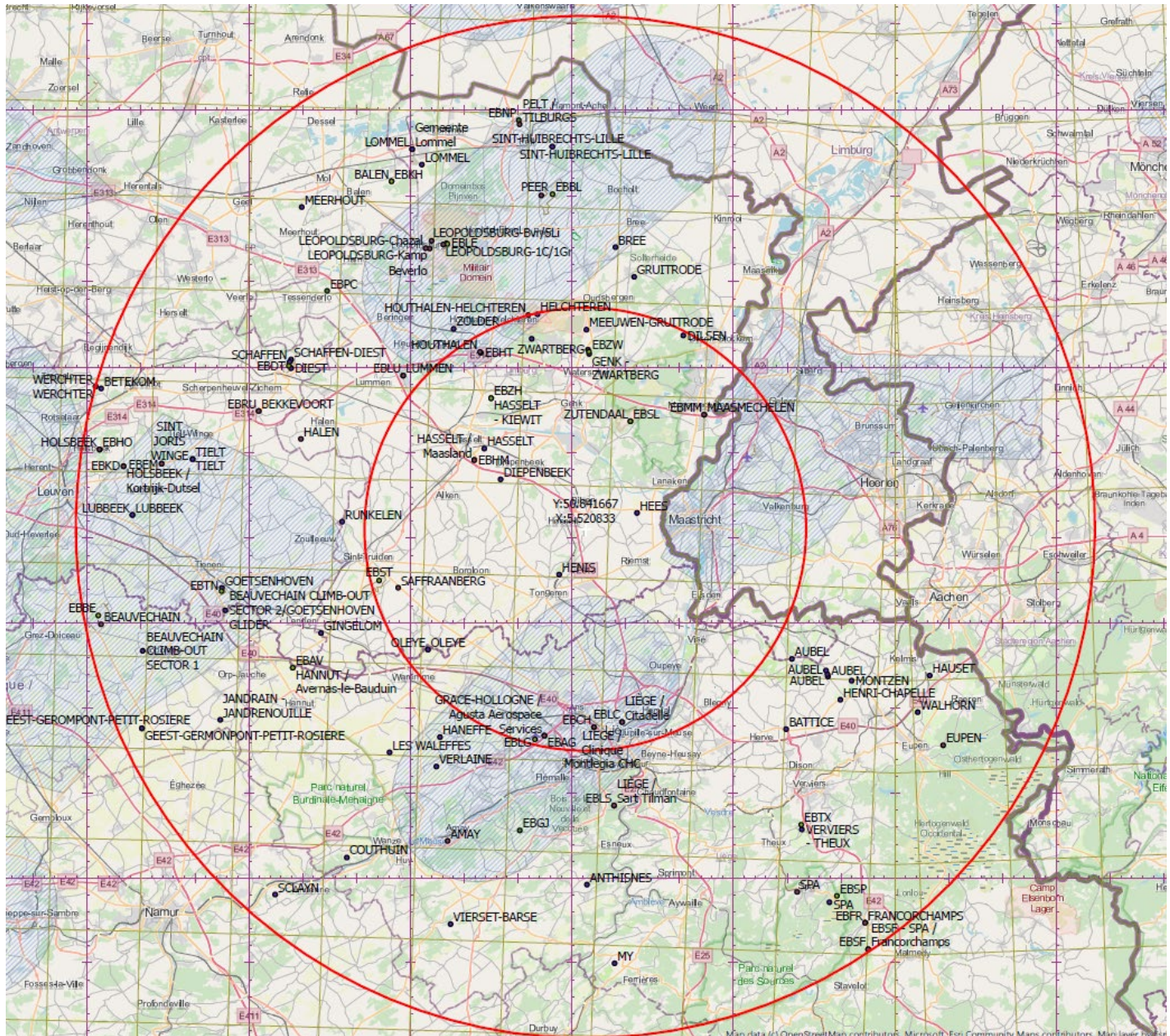


Figure 2: Map with airfields for CoG Alden Biesen
